1.	The total number of section of the school shall be restricted to 17 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation by laws.			
2.	Compliance of the points no. 1 to 2 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

1	If school wants to increase/decrease sections further, then, school will take permiss from the board as per prevailing norms.			
2	School is required to maintain section teacher ratio 1:5 as per clause 5.4 of Affiliation bye laws.
